Catherine Wood, Executive Director, Benefits

- Open Enrollment for 2018 Benefits begins October 17-31
- Person averages only 15 minutes in their benefit selection
 - Need to understand all of your benefit options
 - Encourage to invest AT LEAST 15 minutes
- What is included in Open Enrollment
 - o Health, Dental, and Vision insurance
 - Accidental death & dismemberment (AD&D) insurance
 - Health care FSA
 - Dependent day care FSA
- Even if you do not plan to make changes in 2018, you need to login to MyVU Benefits to:
 - Confirm current elections
 - Confirm working spouse coverage, your dependents, and beneficiaries
 - Attest to tobacco use

- Direct Go For The Gold wellness credit
- No health plan design changes
 - Very modest premium increases
 - Two options to choose from: Aetna Plus & Aetna Select. Aetna Health Fund Plan will be discontinued in 2019
 - Accidental death and dismemberment: add all *eligible* covered family members as dependents
 - Salary bands are simplified from five to three
- Retirement Plan Matching Contributions
 - Vanderbilt is beginning to match up to 5%
 - The elderly averages \$240,000 spent in medical bills post-retirement
- New Partially Benefits Eligibility Requirements
- Ask Alex is back! It can help selecting the health plan option or FSA that's best for you
- Benefits you can change any time:
 - Life insurance
 - Enhanced Short Term Disability
 - Long Term Disability
 - Retirement plan contributions and investments
 - Discounted pet, auto, and home insurance
- Open Enrollment labs are scheduled for Oct 18, 20, 24, 26, and 31

- \$100 spousal fee only applied to Health Coverage, not dental or vision

Josh Vincent, Principal IT Consultant, SkyVU

- SkyVU Timeline
 - Currently in "Training" and "Cutover" process
 - Go-Live is scheduled for Jan 1
- SkyVU website contains keys dates for the transition
- Cutover Planning
 - Complete HR changes by the end of November
 - Do not process HR changes that aren't effective/needed until January 1 or after. Those will be completed in Oracle starting in January
 - Place December orders as early as possible
 - Plan expense report processing to be complete by Mid-December which includes OneCard approvals
- Review of Cutover Milestones
- Timekeeping will begin in Oracle Cloud BEFORE January 2018
