They cause conjunctivitis and corneal burns in the eye and produce chemical burns, particularly on areas where the skin is broken. Ingestion produces a corrosive action to the mouth, throat, and digestive tract which can include symptoms of stomach pain, nausea, vomiting, bloody diarrhea, swelling of the throat, blood in the urine, and shock. Inhalation irritates the nose and throat producing cough, chest pain, bluish skin, fever, nausea and vomiting, shortness of breath, difficulty in breathing (onset may be delayed by several hours), and pneumonia. Fatalities have occurred by inhalation and ingestion., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
