INFORMAL RESOLUTION AGREEMENT

This agreement documents the terms of resolution regarding the Formal Complaint that was filed by under Vanderbilt University's (the "University") Formal Grievance Protocol (the "Policy"). In lieu of a formal finding of a violation or no violation of the Policy, the parties have agreed to an informal resolution of the Formal Complaint. The Informal Resolution Process is a voluntary, structured interaction between the involved parties and a facilitator to resolve the allegations following the filing of a Formal Complaint and before a determination. All parties, the informal resolution facilitator, and the Title IX Coordinator must accept the terms outlined for the Informal Resolution Agreement to be effective.
